**NOTE: Effective 7/1/2021, DOC has shifted capacity of approximately 90 congregare sober living beds to scattered-site apartments with intensive services. DOC is no longer funding Phoenix House (Burlington, Brattleboro, Barre, Bellows Falls), Northern Lights (Burlington), SEALL (Bennington) HCRS (Springfield), or Samaritan House (St. Albans). However, total bed capacity funded has increased by more than 20. More flexible & local housing options are available to meet individual needs, and support those leaving incarceration to return to their home community.**
