The Department of Corrections is obligated to provide incarcerated individuals a means of communication with family. This contract provides a multitude of services including Inmate Commissary, Telephone Services, Video Visitation, approved entertainment, and other Technological Kiosk solutions for incarcerated individuals statewide at no cost to the State

Services for this contract are charged directly to inmates and commissions earned from those purchases fuel the Inmate Recreation Fund. As such, this has historically been a "Zero-Dollar" contract.

This Amendment extends the term of the contract from ending on 04/13/2023 to end on 04/13/2025.

The PAT review team recommends CIO approval of this contract amendment.

**STATE OF VERMONT
CONTRACT AMENDMENT**

It is hereby agreed by and between the State of Vermont, Department of Corrections (the "State") and Global Tel*Link Corporation, with a principal place of business in Falls Church, VA (the "Contractor") that the contract between them originally dated as of 05/17/2017, Contract # 34430, as amended to date, (the "Contract") is hereby amended as follows:

- I. **Contract Term.** The Contract end date, wherever such reference appears in the Contract, shall be changed from 04/13/2023 to 04/13/2025.
- II. **Attachment B, Payment Provisions.** The payment provisions are amended as follows:

To add to Attachment B, Page 42 (continued on Page 43), Section 2 as paragraph 9:

Inmate Communication & Gaming Services Charged to the State

Contractor shall request approval of State before adding new products coming from BETA test modes. Costs will be determined for products and shall be agreed to pending States approval.

Taxes Due to the State. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, the Contractor is in good standing with respect to, or in full compliance with a plan to pay, any and all taxes due the State of Vermont.

Child Support (Applicable to natural persons only; not applicable to corporations, partnerships or LLCs). Contractor is under no obligation to pay child support or is in good standing with respect to or in full compliance with a plan to pay any and all child support payable under a support order as of the date of this amendment.

Certification Regarding Suspension or Debarment. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, neither Contractor nor Contractor's principals (officers, directors, owners, or partners) are presently debarred, suspended, proposed for debarment, declared ineligible or excluded from participation in federal programs, or programs supported in whole or in part by federal funds.




